We have received notification from the Dental Council of Hong Kong (DCHK) on 5 January 2024 regarding the subject. Under the Closer Economic Partnership Arrangement (CEPA), registered dentists in Hong Kong who are permanent Hong Kong residents and have been practising for more than one year are eligible to apply to take the subject Examination. The DCHK is tasked to receive and vet applications for the examination. Members who are interested to sit for the 2024 NQE are required to **submit their applications online by the application closing date of 4 February 2024.** Applicants who have already submitted their applications online before this deadline are required to submit the supporting documents in person to the DCHK Council Secretariat for vetting and onward submission to the National Medical Examination Centre **on or before 7 February 2024.**
