Dear Members and Dental Colleagues,

The 75th Anniversary of HKDA - HKDA Voting Appreciation Programme

As one of the activities marking the 75th Anniversary of HKDA, the HKDA Council is introducing the “Voting Appreciation Programme” (“Programme”) to members and dental colleagues who have voted in the 2025 Legislative Council General Election (“LegCo Election”) on 7 December 2025 to recognise their support for the LegCo election. Under the Programme, members and non-member dental colleagues who vote at the coming LegCo Election can enjoy a one-off refund up to HKD500 for payment made to HKDA from 11 December 2025 to 31 December 2026 for HKDA’s activities and services¹ (for members) or HKDA entrance fee/ membership fee (for non-members) by the following steps:

STEP 1 Registration – Complete the Google Form
